Letter from the Management Team

Families in our community still have to make the difficult decision between paying school fees and paying for other necessities such as food and utilities. By sponsoring children to an education we help the parent to put food on the plates of their children.

2019 saw a small growth in school numbers as we admitted five new children requiring sponsorship. They received an education, uniform, books, stationaries and food free of charge. We also assisted three families with our goat empowerment programme.

It was a year of intense learning and growth for us. One of our priorities was to improve communication and team spirit between management and the team.

Another challenge we undertook was to consider the impact of the new CBC on teachers and pupils and to gain an understanding of the types of challenges teachers would be faced with. This involved extensive research, gathering the plethora of information available to synthesis a coherent program for Roko 20 Academy.

We ended the year with a strong team of staff who are working well together to implement the new national Competency Based Curriculum ("CBC"). It remains now for us to support our teachers in implementing this change through professional development workshops and by engaging instructional coaching so that Roko 20 Academy becomes a vibrant place of learning for our pupils to thrive and succeed.

Thanks to the generosity of our donors and supporters our bank balance for 2019 remained healthy throughout which enabled us to continue developing the school.

We hope you will find in this yearly report useful information and the motivation to continue helping us.

SCHOOL POPULATION

As the Community has more confidence in Roko 20 Academy, due in part because of stability with staff, we noted a significant increase in the number of pupils enrolled.

Enrolment for 2019 reached 103 children at the end of the year, an increase of 5 children compared to the beginning of the 2018 school year.



The children were distributed among the different classes as follows:

PP1 - 10

PP2 - 13

Grade 1 - 19

Grade 2 - 14

Grade 3 - 18

Grade 4 - 14

As of the beginning of the new school year January 2020 we have 119 pupils. We opened a new class 6 and now there are 8 classes: 2 pre-primary classes (PP1 and PP2) and 6 primary classes (class 1 to 6).

FINANCIAL REPORTING

We continue to have clear accounting lines and have invested time in carrying out a comprehensive and realistic budget.

The school's financial organisation rests on two entities:

- A UK Charity
- A Kenya entity, operating the school

The UK Charity is operated by Tracey Neale-Ferreira. It is officially registered as a Charity with the HMRC in the UK. It serves as the entry point for most donations. All money received by the Charity is transferred to the Kenya entity – save for some minor expenses made in the UK.

The Kenya entity is operated by Tracey and Job. Most of its income comes from transfers from the UK Charity. Last year we noted a small increase (approx. 8%) in fees paid by the fee-paying children.

Both entities are subject to rigorous and transparent accounting procedures.

Accounts are audited by independent auditors at the end of each financial year.

Income received through sponsorship is not enough to cover the full cost of providing an education for a child. Expenses such as books, stationeries, uniform, food, transport and teacher's salary amount to 46,090 KSH (£353) per year. Note that the amount of a child sponsorship (around £216 per year) falls short of these costs.

The global expenditure reached 4.747 Million KSH.

The full cost of providing an education for a child is around 46,090 KSH (£353) per year. Note that the amount we receive in child sponsorship (around £216 per year) does not cover the full cost.

The salaries are the main expenditure, followed by vehicle and insurance costs, and special projects.
