Our not-for-profit NGO carries activities in the second capital city of Mongolia, which is home to over 100 000 people. Our organization’s activity is dedicated to providing qualified English language training to children and women free of charge and protecting them from any violence. Our project has following three steps:

- The first step, English Training Center, has been carrying activity successfully.
- The second step is to establish Temporarily Shelter for the victims of family violence and
- The third step is to build own Temporarily Shelter building in a fresh air location in Darkhan-Uul province.

We have been successfully started English training project

Based on our facilities which we financed from our own recourse, we started our Free English training in July, 2018 and we have involved over 200 people in the training in over 16 months. Some of our students take IELTS and TOEFL tests successfully and got their desired points to study abroad.

Why we started English training:

In any countries, knowledge of foreign language, especially English is required for all occupations and it becomes one criterion for any job these days. It has been certain time since this standard has been customized in Mongolia. The opportunities to have job and income will be opened for whoever studies English. It has been already proven in real life that learning English can open the gate to escape from poverty, and it is life-long guarantee for our life, valuable mental asset which

can't be stolen by anyone and big chance to study abroad, develop themselves and keep up with the world - therefore develop our country with the knowledge and experience which are gained abroad.

Whereas in UB, the main center of education and culture of Mongolia, many people who has recognized the importance of English have their children study in English training centers or schools which have high tuition fee, people in rural areas such as Darkhan city or those who don't have sufficient financial capacity are abandoned from the education. Some of them study English at their schools, unfortunately there are many children who can't attend even in school.

When we conducted a survey before we start our training, there are hundreds of children in the vulnerable group wanted to learn English but they have only two choices to improve their language.

1. To be involved in the Training center which carry activity in Darkhan city.
2. To attend in the English class at their schools.

The former way which says training centers in Darkhan has following disadvantages according the people who are involved in the questionnaire

- Tuition fee is too high
- Many students who have different levels are study in the same class
- The training is not qualified and the students aren't satisfied with the course
- Children, girls and women tend to be discriminated
- There is no place to prepare for international tests such as IELTS and TOEFL

And the second way of learning English at school has also have following disadvantages

- The class has many students; therefore it is impossible to work with every student and listen to them and but language should be taught based on the real communication
- Student books don't have enough information, some of them are very hesitating
- Students can't participate in class activities because they are afraid of mispronouncing or making mistakes
- Teacher's English level is lower.

We and our staff have enough experience in educational and humanitarian sector. For example, our teachers had been working in the leading English teaching organizations in Mongolia such as Santis Educational Center, Jet English Training center, Thompson and Thompson Legal Translation and English training center, and Oyu Tolgoi project, one of the biggest mining project in the world as English teacher, legal advisor and social worker... etc.

How we started:

We started our project in a small rent office in Darkhan with 2 English teachers and one director (manager). We repaired the office and furnished the office with training desks, chairs, bookcases, whiteboards and computers. Then we chose suitable books for students and bought them.

How our English Training goes:

First, the participants take placement tests to choose right classes.

Second, participants choose their appropriate hours.

Then, the class lasts for four weeks, 5 days a week and the participants take final test of the course. If they pass the test (70 per cent or more), they are allowed to study next level. Most of our students pass their final tests and go on the next level. If they don't pass the exam they will study at the previous level again or study the class themselves and take the test again. Even if they retake the class and don't pass the test, they will be eliminated from the project.

PROTECTING CHILDREN AND WOMEN FROM VIOLENCE

Why we should start the Temporary Shelter for Victims of Family Violence Project

Darkhan city has over 100 000 population and there is statistic that says at least 10-15 per cent of the population become victim of family violence and most of the victims or 70-80 per cent of the violence are children and women. Women and children are beaten and murdered as the victim of jealousy, lover and excessive drinking of alcohol by their spouse. Most violence happened during night and the victims don't have place to stay overnight. Even they escaped from the place of the violence, they can't go farther from the place because there is no place to go. Especially in winter, it is very dangerous to be outdoors, because it is dangerous the victim to be frozen.

Crime and offense caused by family violence is committed in family range. There are many reasons to cause the violence such as overdrinking alcohol, poverty, unemployment and jealousy. But the root of it is related to personality and upbringing of the person.

According to the crime and offense statistics, most of the acting people are men - husband, bed fellow, step father or son-in-law.

Family violence is not an accidental action, but it is planned to reach certain goal. The victim is under the control of the acting person of the violence, therefore, this crime slips out of control. Committing crime due to family violence means the violence reached its peak.

Children become victims when their parents are alcoholic, don't pay attention to the children, get divorced or they are discriminated by their step mothers and fathers. Apart from these, recent years many children also become victim of sexual violence.

Children who grow up in families which have family violence have been affected directly and indirectly by the violence. Directly affected children are beaten or undergo sexual violence.

Indirectly affected children are not beaten or undergo sexual violence, but they become diffident, don't pay attention to their school, and don't want to go home.

Both of the victims don't want to go home and they may become stray children or even though they don't become stray children, they may become acting people in the future.

When we conduct a survey about the project, many people suggested us to establish temporary shelter and this project has a lot of expectation. In the frame of our survey, we had a meeting with the authorities of General Office Police of Darkhan-Uul province and we have suggested

cooperation with the operation of this project if our project has the financial aid. They appreciated with our initiation and promised to cooperate with our Temporary Shelter Project operation.

Our temporary shelter staff consists of:

- One doctor and psychologist
- One legal advisor and social worker
- Two security guards (2 shifts)
- One English teacher

We have the general facilities (4 room office including kitchen), and human resource of legal advisor, social worker and English teacher.

PURPOSE OF THIS PROJECT:

If this temporary shelter is established, the children and women who became the victim of family violence can be safe and peaceful atmosphere until their case is solved at court and get health, social welfare, legal and psychological advice from our advisors. This shelter is specifically designed to provide a safe, family-friendly, therapeutic environment where adults, youth, and children can begin to heal from trauma and establish goals towards self-sufficiency.

The purpose of this project is not only to let the victims of family violence stay for a certain time shelter safely and comfortably at our temporary shelter but also provide them with useful legal information about women's right and how to protect themselves against the violence, how to care for their children what is the role of spouses. Our constant training will improve their confidence and change their way of thinking; therefore they will seek the new gates to escape from violence.

Beneficiaries and Participants:

The women and children of all social layers who became the victims of family violence will benefit from our project. It estimated as approximately 10-15 thousand people in Darkhan-Uul province. We will contribute safety of these people with your assistance.

Our main costs are:

- furnishing
- operation expenditure
- doctor's room
- salary to the staff
- fixed charges (electricity, heating, ...)
