HUMAN RIGHTS FOR WOMEN AND GIRLS WITH DISABILITIES

THE SITUATION

The unanticipated emergence of Covid-19 threat in December 2019 and its spread at a global scale has caused a lot of pain and changes in the society prompting emergency responses including responses by national governments who introduced movement restrictions, closure of schools, hotels/restaurants, public gatherings and religious meetings among others and introduced strict public health guidelines to control its spread in the populations. In Kenya, from 12th March 2020 when the first corona virus case was detected, the Covid-19 threat became real with cases of infections increasing rapidly by the day. The cases of those who test positive of corona virus have continued to rise. On 15th March 2020, the President of the republic of Kenya announced several measures in response to the corona pandemic. Since then, the measures have been tightened with additional measures, rules and guidelines.

Key among the measures announced by the President and Ministry of health have been the national curfew on unauthorized movement between 7pm to 5am every day, cessation of travel in and out of Nairobi City and, by extension, between some counties except for essential service personnel, limitation of visitation to hospitals, passenger distancing in public transport vehicles, working from home policy and many others. Most of these measures are still in effect and even when they are eased out, they will have an after effect lasting for a long while.

In the above situation, the field team at persons with disabilities association – Kitui (PEWDAK) has reported numerous rights violations and challenges facing the persons with disabilities across the County and in particular the women and girls with disabilities.

Regarding the curfew against unauthorized movement, the women and girls with disabilities most of who have physical impairments, have had their already limited mobility further curtailed rendering them unable to get access to essential services and basic needs. The cessation of travel in and out of Nairobi and a few other counties has affected some cases that engage in business who obtain goods from the locked counties. Most cases of disability require company of care-givers to attend to their daily needs including medical services but given the advisory on social distancing and limitation of visitation to hospitals, they continue to be affected negatively. Passenger-distancing in public transport also limits their access to transportation given that they are, in the normal cases, usually discriminated. Many employed cases of women and girls with disability fall in the category of self-employment, private sector and government. With the decreased work volumes due to stay-at-home policy, the self-employed have practically lost their incomes; the private-sector-employed have been laid off or sent on unpaid leave, the government-employed are in-active and therefore unproductive.

The real or perceived violations of rights for women and girls with disability continue to increase with the escalation of covid-19 threat. Even when some of the measures taken by the government in response to the covid-19 pandemic ease up, the violations and impact will in all likelihood continue to be felt longer after.

In this regard, Disability Discovery Association of Kenya (DDAK) is convinced that the situation for women and girls with disabilities during the covid-19 pandemic and beyond requires action to protect their rights and ensure that all responses are mainstreamed and adapted to their needs.

THE URGENT ACTION

a. Proposed action

Upholding human and legal rights, social and economic justice for women and girls with disabilities in Kitui County, Kenya in the covid-19 threat era

b. Objectives.

Disability Discovery Association of Kenya,

- In view of the efforts by the national government, county government of Kitui and related agencies/departments in the implementation and enhancement of the various measures to combat the covid-19 threat;
- In respect for UN convention on the rights of persons with disabilities rallying call that "Nothing about us without us"; and
- In accordance with the UN 2030 agenda for sustainable development goals' recognition that persons with disabilities should be included in plans to manage covid-19 corona virus outbreak,

Has the objective to:

Objective 1: Ensure upholding of the human and legal rights of women and girls with disabilities in the covid-19 era in Kitui County

Objective 2: Ensure the inclusion of women and girls with disabilities in all stages of covid-19 response especially in the prevention, mitigation and monitoring plans by the (national government and) county government of Kitui and related agencies/departments

Objective 3: Ensure the cohesion among women and girls with disabilities in the covid-19 era and cultivate encouragement and helping each other overcome the pandemic related challenges.

c. Intended results

The response to ensure rights and inclusion of women and girls with disabilities during the covid-19 threat era responses by county government of Kitui and related departments/agencies is expected to generate the following results:

Objective 1: Ensure upholding the rights of women and girls with disabilities in the covid-19 era in Kitui County

Result 1: Report of ongoing human and legal rights violations against women and girls with disabilities by the covid-19 threat responses mainly by oversight or omission

Result 2: Analysis of the survival and practical needs of women and girls with disabilities during the covid-19 threat era and attention to most pressing ones

Objective 2: Ensure the inclusion of women and girls with disabilities in all stages of covid-19 response especially in the prevention, mitigation and monitoring plans by the county government of Kitui and related agencies/departments

Result 1: Recommendation for disabilities inclusion in the prevention, mitigation and monitoring plans by the county government of Kitui and related agencies/departments

Result 2: Summary of strategic actions that can be undertaken to build sustainable livelihoods for women and girls with disabilities

Result 3: Framework of engagement during and post covid-19 pandemic to ensure improved status of women and girls with disabilities in employment, health, education, housing, mobility, information and social protection

Objective 3: Cultivate cohesion among women and girls with disabilities in the covid-19 era as a basis of encouragement and helping one another overcome the pandemic related challenges.

Result 1: Unity factors and how they can be exploited during covid-19 pandemic environment

Result 2: Information sharing methods among the target beneficiaries

f. Methodology

The initiative to address the human and legal rights, social and economic justice for women and girls with disabilities will apply qualitative and quantitative methods of data collection as follows:

- 1> Online survey (email, face book, whatsapp) for those who have these services
- 2> Telephone survey (calling and text messages) for those who have these services
- 3> Physical interview (visiting the beneficiaries at their homes) for those who cannot be reached through online or telephone, or who, even when reached have peculiar challenges that require physical interaction or observation

g. Activities

The initiative to address the human and legal rights, social and economic justice for women and girls has the following activities:

- 1> Identifying the human rights violations against women and girls with disabilities
- 2> Identifying the pressing needs / challenges experienced by women and girls with disabilities
- 3> Responding to the most pressing ones
- 4> Recommending disabilities inclusion in county government of Kitui and related departments / agencies measures
- 5> Designing action plan on reduction of vulnerabilities and poverty
- 6> Designing framework for disabilities engagement during and post covid-19 threat to improve socio-economic status
