- 1. 4100 free roaming street dogs are neutered and vaccinated in Kavrepalanchok District (epicenter of 2015 earthquake and rabies outbreak recorder in more than 5 spots, 15 cases).
- 2. More than 10,000 doses of Anti Rabies Vaccination to free roaming Canines.
- 3. RRTR Program collaborated to serve over 1,000 livestock, post disaster, in Shindhupalchok District (epicenter of 2015 earthquake, 30%+ damages in total recorded to happen in this district.)
- 4. Won Writ Petition in Supreme Court of Nepal in 2015 against Gadhimai Mela and for the end of Cultural Sacrifices from Nepal gradually.
- 5. Post exposure Rabies Control and Management Program, collaborative program with DLSO Kavre in Seven Rabid sites.

# SHELTER PROPOSED – AN INTRODUCTION

If you have been cut off of the food that you used to get regularly, it would have changed your prospect and behavior or not? Increased lock down due to Covid-19 pandemics have hard hit the economy leading to closure of shops and sources of food to free roaming canine population. The number of dogs is controlled through regular Neuter programs. But prolonged lockdown has caused dogs changing their behaviors alternatively to more violent due to lack of food sources causing problem to the household livestock population. They are now in danger of counter measure from the society. Some cases already being witnessed. Open roads due to pandemics and dog's search of food in the streets have led to increase in the injuries related to the traffic resulting to more rescue calls (5-7 in a month).

Since we are operating from a small space in our rented home's room, we are not able to hold more numbers of dogs and many have to be returned to the society with some instances of injuries to be cured by follow-up. Some precious souls do have injuries which required them to be looked after for full years since they cannot go back to the community because of different conditions. We have estimated about 50 such dogs needing special attention and care.

We have approach local government bodies and they are positive in providing us necessary space to create the shelter. The cost estimation for 100 dogs (50 long term + 50 regular to be released) is presented below.
