

- Women and men will be part of the implementation of the project, and they will find jobs and preserve the environment by allocating 50% of the economic empowerment program to reduce illegal trade, and 50% of women will be in the field awareness team.

Project rationale:

The Arabian leopard (Panthera pardus nimr) is categorized as Critically Endangered on the SONCS Red List. Yemen has been identified as a key range state for conservation of the Arabian leopard Since more than 15 years, one Arabian leopard has been caught from Wada and currently local people still report that Arabian leopard in Wada'a. The Arabian leopard is threatened by habitat loss, degradation and fragmentation; hunting of its wild prey, and retaliatory killing in defense of livestock (Al Jumaily et al. 2006, Breitenmoser 2006, Edmonds et al. 2006a, Judas et al. 2006, Spalton and Al Hikmani 2006, Al-Johany 2007). Some cases recently reported that Arabian leopard caught for trade from Yemen to neighbour countries.

This proposed project will verify the presence of the Arabian leopard and assess the status of the population and combat the international trade. Results of the research will provide data about the Arabian Leopard population in general. By clearly establishing the existence and extent of the Arabian leopard population in the target areas of the project (Wada'a / Amran Governorate, Wadi Shars / Hajjah Governorate, Al-Dhabianiya / Al-Bayda Governorate). It is worthmentioninh that Yemen has eancted a law Np/ 26 for the year 1995 for the protection of the environment in all its forms which was endorsed and ratified by the resolution of the ministerial cabinet N 260 for the year 2009 which included the enforceability of the law issued previously. This step taken by the Government of Yemen gives a clear indication and desire to take the environmeta; protection a priority in the economic and development plan which should applied unreservedly.

Project overall objective:

- To assess the status and estimate the size of the Arabian leopard population, its habitat, and its prey species in Amran, Hajja and al Al-Bayda governorates.
- Project approach and activities:
- The population of the communities in the targeted areas mainly depends on agriculture and livestock for their money. The total number of residents in the Wadaa area of Bani Sarim district in Amran governorate is (12,595), and in Wadi Shars in Hajjah governorate is (11551).
- people, and in Al-Dbayaniya district in Al-Bayda governorate is (6707). It is considered one of the areas threatened by armed conflict due to the spread of firearms among the local citizens. that threaten the safety of wildlife.
- Residents sometimes resort to selling rare and endangered animals in order to be able to obtain money and spend it on their daily lives due to the lack of self-projects that generate income for individuals, especially weak families.
- There are still existing initiatives carried out by Sanid Organization, Natural Conservation Sector (SONCS), which it
 submitted to the Public Authority for Environmental Protection in Sana'a. This initiative contains reducing risks to
 wildlife during conflicts through coordination with the relevant authorities to deviate from any hostilities in nature
 reserves and areas. The initiative also included monitoring Violations that affect wildlife, especially in nature
 reserves that contain endangered animals and plants.

- It will also launch an awareness program targeting the local community to raise awareness of the dangers of illegal trade and how to coexist with wildlife.

Project impact:

- The project will limit the expansion of illegal wildlife trade, especially the Arabian leopard, in the targeted areas by improving the economic situation of the local community, raising awareness of how to coexist with wildlife and the risks of trafficking in it, and providing
- accurate information about the Arabian leopard in the target areas.
- Project assumptions and risks:
- The occurrence of armed clashes in the Al-Dbayaniya area, as it is located in the areas of contact between the



governorates (Al-Dhalea - Al-Bayda - Abyan) between the conflicting parties. This will be overcome through close coordination with the conflict parties to implement the team's activities safely.

- Lack of oil derivatives, this will be overcome by taking into account the supply of sufficient quantities of gasoline.
- The target areas are active in the Arabian Leopard, which is considered a threat to the team's life.
- Guides will be used in the targeted areas and safe places will be chosen to maintain the safety of the field team.

Long term sustainability and replicability:

- The project will contribute to the formation of an accurate database on wildlife in (Wada'a / Amran Governorate, Wada Shars / Hajjah Governorate, Al-Dhabianiya / Al-Bayda Governorate) in general, which is targeted in the project, and thus will benefit from this data in the work of studies and future research, and will be used to create a suitable environment for coexistence between the local community and the wild animals surrounding them.

A special report for the organization

A Report on the Arabian Leopards in Yemen

Since the outbreak of the armed conflict in Yemen at the end of 2014, there were many Arabian leopards that have been subjected to over-hunting both in their original habitats and the natural protected areas where they reside, according to the cases monitored by the organization. According to Sanid Organization for Nature Conservation (SONC), the most important areas in which leopards were subjected to over-hunting and illegal trade were the governorates of (Lahij - Al-Dhal' - Abyan - Shabwa - Al-Mahra). These areas are characterized by their environmental elements that are punctuated by cracks, caves and deep valleys suitable for protection, and the abundance of water and diverse trees that provide good food for the wild animals preyed upon by the Arabian leopards, which keep them alive and preserve their abundance.



In this report, the violations that SONCS was able to document from several local sources will be highlighted, as SONCS tried as much as possible to investigate the information that was documented through picture, place, date and location on the map. SONCS has not relied on any information about such cases of violations which have not been directly confirmed. SONC has also communicated with all relevant social characters, activists and officials in the areas where violations are reported.

Recorded Trapping Cases:

- On July 6, 2014
- Agroup of hunters hunted 3 Arabian leopards in the Al Shuaib area, Al Dhale' Governorate, as shown in the attached photos. See picture no. (1a &1b)
- On October 22, 2014
- 3 hunters hunted 2 Arabian leopards in the Hudub area in the Hawf Natural Protected Area, in Al-Mahra Governorate. See picture no. (2a&2b)
- December 5 2014
- A man in his forties, with his friend, hunted an Arabian leopard in the (Lab'ous Hateeb) area in Yafa' District, Lahj Governorate. (13.865651,45.284277) See picture no. (3)
- November 5 2016
- A hunter killed a leopard with a Kalashnikov (machine gun) while gambling with his friends if he
 could shoot the leopard or not, in Juban area of Al-Dhal' Governorate (13.984565,
- 44.852080). See picture no. (4)

- February 22, 2017
- A young man in the third decade of age hunted a leopard in the "Hallak" mountains in the Mudiyah district of Abyan governorate, after the people in the Talh region suffered from fear as a result of the leopard devouring their sheep and threatening their lives. See picture no. (5)
- December 22, 2017
- A group of hunters in the Juban area of Al Dhale' Governorate (13.984565, 44.852080), hunted an Arabian leopard and then slaughtered it and slipped its skin on a tree trunk as shown in the picture. See picture no. (5)
- May 21, 2018
- Two leopards were killed in the mountains of Al-Shuaib area, Al Dhale' Governorate,
- 13.841652,44.879431 See picture no. (6)
- January 09, 2020
- A group of hunters hunted an Arabian leopard in the Hadd area of Yafa' District Lahij Governorate (13.996128, 45.302339) and slaughtered it. Attached is a video documenting a terrible hunting operation. See Picture (7).
- April 5 2021
- A citizen of the Al-Barakani family in Wadi Shi'b Al-Dhabi (Gazelle Valley) in the village of "Yari" in Al-Hawzn area, Lauder District, Abyan Governorate (13.907841, 46.085867), set a special trap for hyenas hanging on a tree, and was able to hunt a female Arabian leopard late at that night. Residents of the region said that they heard the cries of the Arabian leopard in the early hours of the morning after she fell into the trap, but none of them went to check the source of the sound, and in the morning, they found the Arabian leopard caught by a tree trunk.
- An activist in the region said that an amount of 6 million Yemeni riyals (12,000 USD) was offered
 to the Al-Barakani family in order to buy the leopard, but the family rejected the offer and
 demanded double the amount in order to sell. See Picture (8)
- On July 2, 2021
- Citizens hunted two Arabian leopards, in the "Yari" valley in Shi'b Al-Dhabi (Gazelle Valley), near to Jabal Thara, 9 km east of Lawdar District, Abyan Governorate (13.907841, 46.085867).
- Local citizens said that one of the leopards escaped from the chains while trying to catch him and attacked a citizen close to him, before he was shot and killed. While the other leopard died in the trap moments after the incident, without being shot. (see picture no. (9))
- In April 2022
- Two Arabian leopards were hunted, one of them in the "Aqtan" area of Wadi Bana in the Halaymin District of Lahj Governorate, after a shepherd put a quantity of poison in a dead sheep and left it to be eaten by the leopard that died due to poisoning. The people said that more than 13 goats were died because of leopards while grazing in a mountain in the area. Killing this leopard came a month after a leopard crashed with an 85-year-old citizen in the Labous district of Lahj governorate, southern Yemen. See picture no. (10).
- As for the other incident, it was a female leopard that was killed in the Al-Dabianiya Protected Area, north of Abyan Governorate, and her four less-than-month babies were captured. See picture no. (11).

Smuggling Arabian Leopards out of Yemen:

On January 15, 2020, after chasing unidentified intruders across the Yemeni-Saudi border, the Border Guards in Jizan region in the south of the Kingdom of Saudi Arabia were able to arrest smugglers of Arabian leopards. Their own large canvas bags were searched inside which were 3 Arabian leopards smuggled from Yemen to Saudi Arabia. Attached is a video documenting the reservation on the Arabian leopards. However, no official statement was issued by the Yemeni government acknowledging that it had received the leopards from the Saudi side.



Arabian leopard in Yemen - an update

- Abstract: The Arabian leopard is assessed as Critically Endangered in the IUCN Red List of Threatened Species. Only few recent records were known from Yemen, and those mostly originated from the border area with Oman. However, in the last few years, several reports turned up on social media. They were mostly cases of illegal killing, but often from areas where scholars believed the leopard to be extinct, especially from the Al Dhabiyaniyah region. There was even one report of reproduction. Whilst active in situ projects remain highly unlikely due to the armed conflict, citizen science reports and social media should continually be surveyed to gather all possible information on these largely unknown populations.
- The smallest subspecies of the leopard Panthera pardus is the Arabian leopard P. p. nimr, which is endemic to the Arabian Peninsula and was assessed as Critically Endangered in the IUCN Red List of Threatened Species (Mallon et al. 2008). Back in 2006, Cat News Special Issue 1 presented the known information about the status of this subspecies. At that time, recent confirmed records were only reported from western and south-western Saudi Arabia, western Yemen, and south-western Oman (Spalton & Al Hikmani 2006). In Yemen, there were recent records of leopards captured in the central part of the western highlands, notably around Wada'a, and verbal reports of presence or possible presence in other parts of the western mountains, southwest Yemen, central-southern Yemen, and Al Mahra in eastern Yemen (Al Jumaily et al. 2006). Accordingly, the newest Red List Assessment (Al Hikmani et al. 2023) shows only two small patches as "extant", but three more as "possibly extant", underlying the continuous shortage of confirmed information.
- At the time, some field visits tried to gather more information on the occurrence of Arabian leopards in specific areas in Yemen (e.g. Mallon 2009). In 2009, the Foundation for the Protection of the Arabian Leopard in Yemen (FPALY) was founded as a local NGO. FPALY undertook several field surveys within historic leopard range, conducted education and awareness programmes, and liaised on leopard conservation with national and regional governments. From December 2010 to January 2011, FPALY installed 12 trail cameras in Hawf Protected Area in south-east Yemen, on the border with Oman (Pittet 2011a). On 18 January 2011, two photos of a leopard were taken, and a further photo on 24 February 2011 (FPALY 2011a, b). No photos have been obtained since then. It is not known if a breeding population occurred in Hawf, or whether the leopards photographed were from the known population in Dhofar, just across the border. At that time, a partial (4 km long) border fence was in place. This fence has since been extended and strengthened and now forms a formidable barrier to wildlife, severing connectivity between Hawf and contiguous habitat to the east. Pittet (2011a, b) reported that only older herders were aware of leopard depredation in this region and that people had generally a low and rather mystical understanding of the species. Leopards occasionally discovered in the Hawf reserve are likely transitory individuals from the Oman population.
- In late 2011, a video was posted on YouTube of a leopard captured in Lawdar. FPALY representatives met with the DG of Lawdar to discuss leopard conservation in the area (FPALY 2011c). In 2012, a photograph of an injured leopard captured in Shabwa governorate apparently in a steel-jawed trap, was posted on social media. This area was considered as "probable" leopard range in 2006 (Al Jumaily et al. 2006).
- Since late 2014, Yemen has been in the grip of an ongoing civil war. Armed conflicts mostly negatively impact fauna and flora in the affected areas (Gaynor et al. 2016). It must be assumed that the situation of the Arabian leopard has become even more dire since 2014; but field surveys, missions by the Environment Protection Agency (EPA), and conservation activities of any kind have become extremely difficult. Soon after the beginning of the civil war, it was reported that Arabian leopards held in captivity in Yemen, which would be crucial to be integrated into the conservation breeding programme, were suffering up to starvation (Bürki & Breitenmoser 2016).
- Photos of leopards killed or captured have continued to be posted on social media. Since 2016, one of the authors (AAF) has collated online posts. Many of the online reports originate from the Al Dhabiyaniyah region of southern Yemen, with some from other locations in southern Yemen (Table 1). At least 10 leopards were estimated to have been killed or caught in Al Dhabiyaniyah from 2015 to 2021 and the EPA has investigated at least 18 cases of capture or killing in this region. In September 2021, OB received reports of "several cases of killing" of leopards including a recent case in Al Dhabiyaniyah.
- In March 2022, a report by the Sanid Organisation for Relief and Development (SORD) mentions 22 illegally
 hunted leopards since the beginning of the armed conflict (SORD 2022). The Sanid Organization for Nature
 Conservation (SONC) sent a report to the IUCN SSC Cat Specialist Group in May 2022 listing 21 cases of
 leopards (including 4 cubs) illegally killed since 2014 (SOM 1). These included many of the reports referred to

above from Al Dhabiyaniyah, with others from Lawdar and Hawf (Fig. 1). Additionally, there was an attempt to smuggle three leopards across the border into Saudi Arabia.

- Al Dhabiyaniyah is a remote mountain region situated where the borders of the three governorates of Al Dalie',
 Al Bayda and Lahej meet. AAF has visited Al Dhabiyaniyah to raise awareness of the persecution and the
 importance of this leopard population, and met with local leaders and negotiated agreements between them
 on behalf of the Environmental Protection Agency (EPA) to stop the persecution. The number of posts and
 photos of leopards captured or killed in this region since 2014, plus the verbal reports of presence and
- depredation given to AAF during his visits strongly suggests that the region harbours a leopard population of unknown size but one that is clearly in great peril from the ongoing persecution. A short video sequence of a leopard was obtained recently in Al Dhabiyaniyah. It is unclear whether these reports represent a single population, several nuclei, and/or animals moving between them. The approximate location of the recent leopard incidents and main locations in Al Dhabiyaniyah are shown in Fig. 2. There are very old records of leopards from Al Bayda, and some more recent unconfirmed reports of presence in this general area, but the occurrence of a breeding population here has been overlooked until very recently, including the latest review (Jumaily et al. 2006). In late 2023, the office of the Prime Minister issued a draft decree declaring an Arabian Leopard Reserve in Al Dhabiyaniyah covering approximately 6,765 km2 (two core area totalling 1,067 km2; buffer zone 1,857 km2; utilization zone 2,940 km2).
- The precise location of most of the other incidences of killing and capture listed in Table 1 is not known, and the map (Fig. 1) is therefore not very accurate.
- An additional Facebook post sent to AAF came from a local biologist in Shabwa governorate, farther to the
 east, who said local Bedu reported hearing leopard vocalisations and depredated livestock in the Kur al Awaliq
 mountains.
- It is believed that leopards once occurred all along the mountains of western Yemen (Al Jumaily et al. 2006). The latest confirmed evidence is leopards captured in the Wada'a area of Amran governorate in the late 1990s-early 2000s. No social media posts or other information referring to western Yemen have been reported so far. Whether leopards survive in any part of western Yemen is not known, though there have been local reports of presence at several sites in the last 10 years. However, field surveys have been very few, and some areas are difficult to access, such as Sa'adah governorate in the NW on the border with Saudi Arabia.
- It is impossible to establish the exact number of different events from the various sources, but indeed, only two pictures were presented by both, AAF and SONC. We assume that there is some overlap between the different sources, but each report also contained events not listed in the other one. At least 20 leopards mostly killed animals have been recorded from areas with few or no former records. The fact that Arabian leopards in Yemen are readily killed is worrying, but the extent of the cases seems to indicate that the distribution of the leopard in Yemen may still be larger than previously assumed. Sex and age of the animals killed was mostly not reported or not visible from the photos; we cannot assess how many of the dead leopards might have been dispersing males outside the permanently occupied areas. One case of the killed female in Al-Dhabiyaniyah area, Abyan governorate, with its four "less-than-month" old juveniles (see SOM 1, Picture 11), proves reproduction in this area.
- Al Hikmani et al. (2023) estimates the Arabian leopard population in Yemen to be fewer than 50 individuals, but this is highly speculative. They assume that the leopard may still exist in five sites, namely the northern part of the western highlands (between Sa'dah and the Saudi border), the central-western highlands (Jebel Bura'a), southwest Yemen (between Taizz and Ad Dale), southeast Yemen (Lawdar area in Abyan governorate) and Hawf in Al Mahra, as already suggested by Al Jumaily et al. (2006). It is unrealistic to expect reliable density estimations in Yemen in the near future, but consistent collection of citizen science data may shed some light on the extant distribution. Social media seems to be a promising source to detect leopard records from Yemen. We encourage all who have access to such information to collect as much details on leopards in Yemen as possible and share them with the conservation community.


