Help 300 marginalized women and girls in Yemen

Target location:

Yemen, Hodeidah governorate (Alhawak, Almina and Alhali districts)

Starting date: 10 Oct 2020

End date: 31 Jan 2021

A. Background & General Context

After five years of continuous war, millions of people are hungry, ill, destitute and acutely vulnerable. A staggering 80 percent of the entire population requires some form of humanitarian assistance and protection. Three years ago, Yemen experienced the worst cholera outbreak in modern times and for the past 18 months. Yemen has the fourth largest number of displaced persons in the world. Two-thirds of all Yemenis are hungry, and nearly half do not know when they will next eat. Twenty-five percent of the population, suffer from either moderate or severe malnutrition, including 2.1 million children and 1.2 million pregnant and lactating women. One of the threats facing Yemen is a COVID-19, which has been present since March and is spreading unmitigated and unchecked across the country¹.

According to Yemen National COVID-19 Preparedness and Response Plan², the severity of suffering and unmet health needs for vulnerable populations, are shocking, as the current situation with high burden of communicable and non-communicable diseases, inability to respond adequately to COVID-19 outbreak could lead to millions of people dying from complications of existing high prevalence of underlying medical conditions and caseloads of preventable diseases/illnesses, including communicable diseases such as cholera, measles, dengue and diphtheria as the health system is too weak to cope with the high burden of these diseases. Public health officials warn that the combination of extreme vulnerability and low general immunity puts Yemen at exceptional risk. Unless steps to suppress and address COVID-19 are immediately scaled-up, the virus is likely to spread faster, more widely and with deadlier consequences than almost anywhere else.

B. Project Summary

The project overall expected impact is to help addressing COVID-19 problems & challenges on women, girls, marginalized and people with disabilities in three districts in Hodeidah governorate.

The project overriding goals to support 300 marginalized, vulnerable women & girls in Hodeidah through provide a sustainable income sources, and improving their exits livelihood in order to recovered and protected their lives. In addition to that, the project will educate 1,500 marginalized, vulnerable women & girls on COVID-19, which will improving their knowledge on COVID-19 prevention, control, and case identification to enhancing public health status of the vulnerable affected people in Yemen – Hodeidah.

The project will used an innovative, evidence-based model that leverages the voices, talent, and leadership of marginalized women & girls at their communities, and involving the national women's organizations to design & suggest a suitable options in order to recover, improve their exits livelihood & enhancing a sustainable income sources for them.
