## ABOUT CARE CONTINUITY CHALLENGE INITIATIVE

**Summary:** Care Continuity Challenge Initiative is the first initiative of Fair Life Africa Foundation. It offers packages of care and support to street children, as well as vulnerable single mothers, whose children are at risk. CCC Initiative (CCCI) provides clean, comfortable and child-friendly environments for street children to meet others of like experience, to make friends and to rest from the inappropriate demands of homelessness and poverty. With a firm belief that children should be cared for in a family environment, we will investigate and assess each child's situation, re-establishing family links where possible, as empowered and constrained by the law and the child's best interests and wishes.

CCC Initiative also provides opportunity for those who are committed to rehabilitating from the streets to reside safely and enrol into local schools. CCC Homes will receive and retain children based on set criteria, having investigated family origin and the causes behind that specific child's experience of homelessness. Resident children will also be supported through the provision of counselling, regular health check-ups and follow up treatments, tutoring and vocational training, and will participate in relevant programs and functions. Children will continue to receive support until they are 18 years old or decide to move on, and will be supported in their transition to adulthood and employment by mentors.

**Care:** CCC Drop-In centres offer a point of contact with children who may have run from home, are working on the streets or are orphaned and homeless. They are supported and understood, given the opportunity to play, clean up, feed, rest and begin to dream about their future.

**Continuity:** Having identified the street children, and gained their confidence in time, our workers will investigate the cause of their current condition. Families in need of support - financial, medical or therapeutic – will be assisted to enable reconciliation and stability.

**Challenge:** Offers orphans and children for whom return home is unsafe, the opportunity to reside in our CCC Homes, with comprehensive support. They will attend school and/or learn a trade, receive medical care and nurturing, counselling and mentorship.

**Services:** Outreach, Meals, Shelter and Amenities, Clothing, Vocational Training, Life Skills Training, Recreation, Counselling, Mentorship, Family Tracing, Family Support (Training, Education, Financial and Medical), Child Protection, Long-term Accommodation, Education, Medical Support, Home Care and Follow Up.

**Beneficiaries:** 1. The Children – They are abandoned, orphaned and vulnerable children, who may not have hope apart from our assistance and intervention in their lives. By changing their stories, we are changing their world and ours.

2. Their Families – The basic unit of any society, and the endurance of our culture and values. Affected families may be restored from the depression of poverty and conflict.

3. The Community – Where the social security structure is absent or has fallen, we are all at risk. If unsupported, they may become the downfall of a nation. Timely and appropriate support will impact the immediate community, and will be felt abroad and for generations to come.

## ABOUT CCC RESPITE PROJECT

**Project Goal:** For the reconciliation, rehabilitation and reintegration of street children with their families for a secure and stable society.

**Background:** You may have seen them on the street, begging at the traffic lights. Like most people, you probably prayed for the lights to change before they come to your window. Or could you be one of the few whose heart was touched by their plight? You may have even heard stories about how they return home after begging, to give back huge earnings to exploitative parents or guardians. Perhaps you have even seen them on the streets at night, selling their bodies in dark corners. Sights like these can be heartbreaking, and it is right for us to seek a solution. Commonly known as street or homeless children, they are often referred to in many other unfriendly names around the world. Who are they? Where do they come from? Why are they on the streets? And what can be done to help them...?

A street child is a young person under 18 years, who lives on the streets, fending for themselves and their dependents, and usually does not have a home to return to. This definition includes those children who may return home, but spend their waking hours in employment on the streets. These are children on the streets, where as those without a home are children of the streets. In every corner of the world where they are found, these children are subject to abuse, neglect, exploitation and even death, being the target of criminals and hatemongers alike. Kuramo Beach in Lagos had one of the largest gatherings of street children, and was closed down due to disastrous ocean surges in 2012. Rain or shine, the children would sleep on the bare beach sand, and a countless number have lost their lives to the ocean waves. Join us to transform the life of a disadvantaged, discouraged and disillusioned child.

**Approach:** Working from the understanding of the child's right to life, to play and recreation, to family and social association, to be free from abuse and exploitation and to receive education; the project aims to redeem the lost childhood of the street child. Often accused and abused, they need the advocacy and protection of concerned adults, and to be empowered to strive for their full potential. In light of the hard experiences of the child adjusted to street living, interventions will be sensitive, but assertive, and every effort will be made to resolve issues at home to prevent a return to the streets. It is our belief that it is preferable for a child to live with their natural family, or surrogate family, than in a residential facility.

**Plan:** The CCC Respite Project is currently available only for boys, as street boys and girls need to be supported in separate facilities. It provides a transitory programme to support 12 boys at a time off the streets, enabling them to go to school (or learn a vocation) and reside at the Home for one academic year. The boys are rescued from the streets, rehabilitated and accommodated in a clean, safe and child-friendly facility. Each child is allocated a social worker and a support worker, and will also join two sets of group. One is a counselling group, and another is a competitive group. These enable the children to form identities, develop their potential, and feel solidarity.

There would be issues of abuse and exploitation, poverty and/or sickness that will need to be addressed and overcome before a safe and secure transition back home is made. During their stay, children will be supported to visit and spend periods in their homes. Social workers will make recommendations for continued assistance and/or referral of children with specific or additional support needs. Alternative support through fostering and legal guardianship will also be considered and sought. Support for families will be phased in throughout the programme, and children will be followed up for a minimum of 12 months after reconciliation, to ensure complete reintegration back into society and quality control.

## FUNDING REQUIREMENTS

**Setting Up:** The Founding Trustees have provided, from their own resources, the following start-up requirements for Fair Life Africa Foundation:

- A Transit Home and Office in Gbara-Lekki, to accommodate and rehabilitate 12 children;
- Two motor vehicles for use by the CEO and Social workers for administrative and outreach;
- Furnishing of the Home and Office, including renovation of the grounds.
- Capital for operational expenses to date.

**Further Needs:** The following has been budgeted for the continuance of its street child project in 2014:

- Projected annual operations budget – N20,000,000 (at less than N2mil monthly)
  - Administration – N12,000,000 (includes wages, fuel consumption etc)
  - Care/Outreach – N4,500,000 (includes feeding, clothing etc)
  - Empowerment/Follow up – N3,500,000 (includes family support, training etc)
